# Wilberforce University Alumni Association Election Notice

In compliance with the Constitution of the Wilberforce University Alumni Association as amended August 7, 2021, the general membership is herewith notified of five (5) vacancies for the Alumni Board of Directors.

## **Nominating Procedures**

- 1. Any alumnus desiring to fill 1 of the 5 vacancies on the Alumni Board of Directors may nominate themselves for the position. Nominations may also originate from Chapters or a group of Alumni.
  - A. Nominations must be received by WUAA P.O. Box 370 Wilberforce, OH 45384-0370, with a postmark date no later than January 2, 2023. Nominations may also be submitted electronically to the Committee Chair at bibbkenneth@yahoo.com.
  - B. Candidates for a position in the Association must be financial and active with the Association, including having registered and attended at least one Annual Conference, and if residing in an area where a local chapter exists, they must likewise be financial and active.
  - C. For those nominees residing in an area where a local chapter exists, you must submit a letter of endorsement from the chapter president or vice-president attesting to your active status.
  - D. For those nominees residing in an area where there is no local chapter, submit a letter of endorsement from an alumnus who can attest to your support of the University and the Association.
- 2. Each nominee must submit to the **WUAA** a brief biographical sketch in narrative form of not more than 125 words, and a clear recent head-shot photograph. Both should <u>accompany</u> the nomination.
- 3. Nominations will be submitted for approval to the Nominating Committee January 21, 2023. If, in their judgment, nominations received is insufficient, the said Committee will nominate additional candidates.

#### **Election Procedures**

- 1. Ballots bearing the names, pictures, and biographical sketches of all candidates will be prepared and available to all financial members electronically or by mail no later than February 7, 2023.
- 2. Voting closes March 14, 2023. All paper ballots must be returned to: **WUAA P.O. Box 370 Wilberforce, OH 45384-0370** with a postmark date no later than March 14, 2023. Ballots not timely returned will be considered void.
- 3. The Election Committee will meet by March 18, 2023, to count the ballots and certify the results.
